4/22/24 - 4/26/24	7:00 am-6:00 pm	(275 Atlantic Avenue)	Site mobilization (Noise / Work will include establishing construction entrances and gates, delivering construction office trailers, and delivery of 30-yd container)
4/22/24 - 4/24/24	12:00 am-5:00 pm	(275 Atlantic Avenue)	Delivery of heavy machinery (Noise / Machinery to be delivered through the Boerum PI. gate / Flaggers will direct pedestrians and vehicles as necessary)
4/24/24 - 4/26/24	7:00 am-6:00 pm	(275 Atlantic Avenue)	Saw cutting of the sidewalk & concrete demo (Noise / Dust (Water will be used for mitigation) / Work will take place inside the perimeter fencing with no public interaction)
4/25/24 - 4/26/24	7:00 am-6:00 pm	(275 Atlantic Avenue)	Waste removal and refuse container pick-up and drop-off (Noise / Removal of site debris / Work will take place inside perimeter fencing with no public interaction)
