9/23/24 – 9/27/24	M-F / 7:00 am – 9:00 pm Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	Timber lagging (Noise / Truck deliveries of wood to the site / Creation of wooden barriers in front of the structural soldier piles to prevent soil from falling inward)
9/23/24 – 9/27/24	M-F / 7:00 am – 9:00 pm Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	Test pit drilling (Noise / Vibrations / Drilling within site perimeter to probe for previous site utilities / Minimal dust expected with mitigation practices to be employed)
9/23/24 – 9/27/24	M-F / 7:00 am – 9:00 pm Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	Tieback installation (Noise / Vibrations / Install tieback supports by drilling through the excavation and lagging into the soil to provide lateral support to the Support Of Excavation (SOE))
9/23/24 – 9/27/24	M-F / 7:00 am – 9:00 pm Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	Smith St. perimeter fence extension (Noise / Extension of the existing fence out to the west travel lane of Smith St. / Flaggers will direct pedestrian travel to the east side of Smith St.)

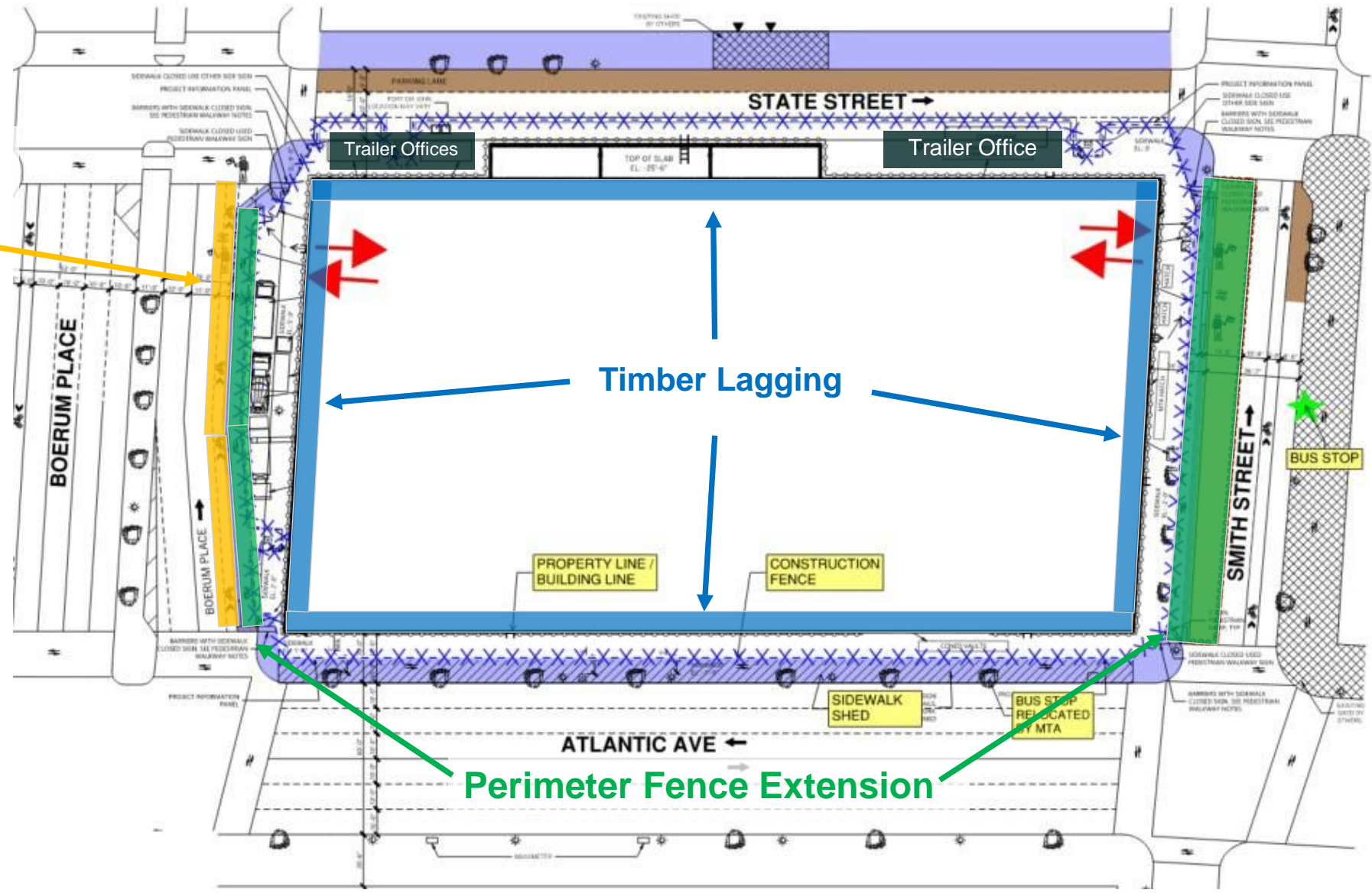
