10/7/24 – 10/12/24	M-F / 7:00 am – 9:00 pm Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	DOC / NYPD officer booth construction (Noise / Vibrations / Minor pedestrian and vehicular impacts (Flaggers on site) / Move existing DOC officer booth closer to the courthouse and construct new NYPD officer booth)

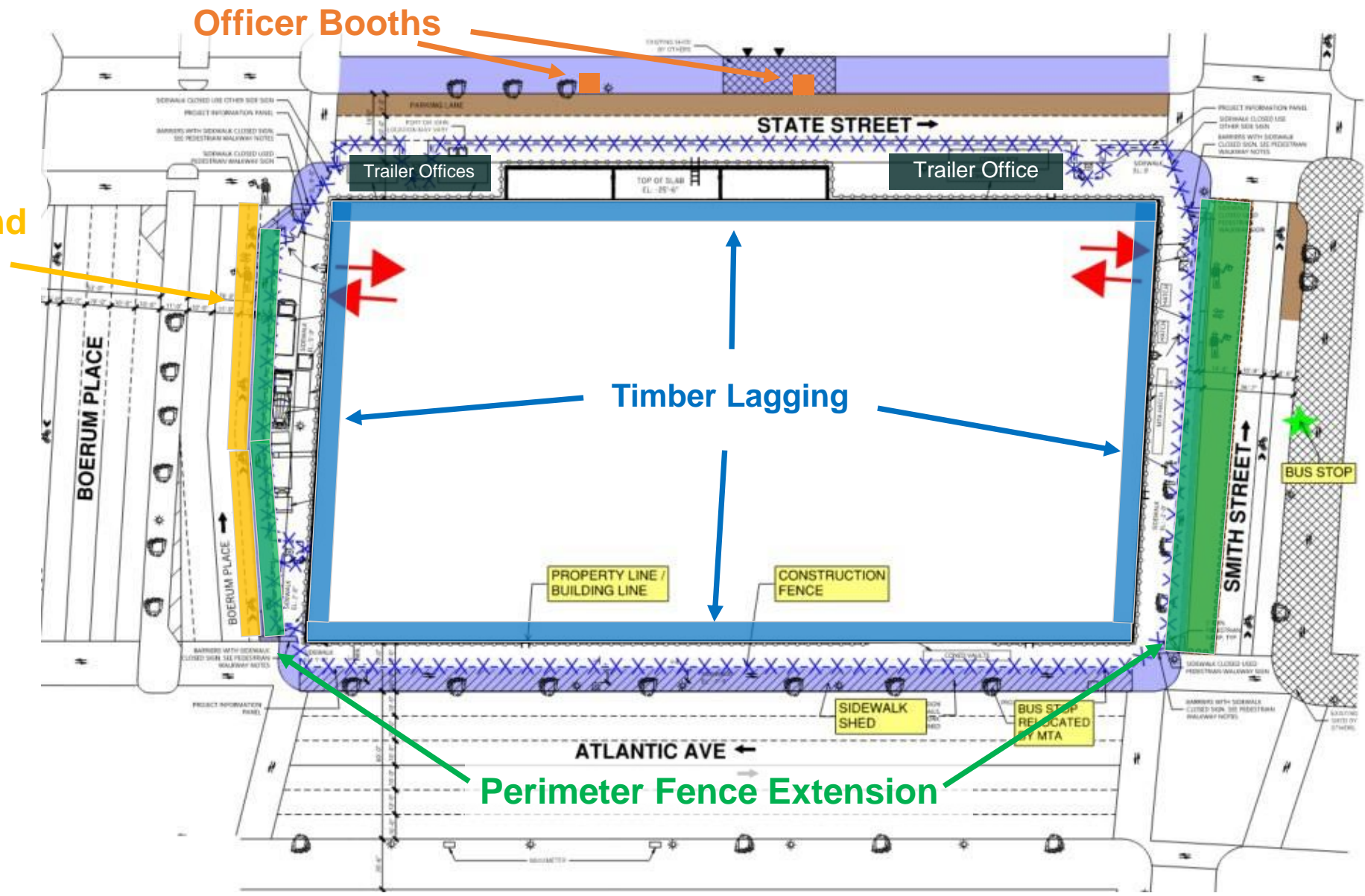
