10/28/24 – 11/2/24	M-F / 7:00 am – 9:00 pm Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	<b>Soil excavation and timber lagging</b> (Noise / Removal of soil around the perimeter of the site / Truck deliveries of Wood to the site / Creation of wooden barriers in front of the structural soldier piles to prevent soil from falling inward)
10/28/24 – 11/2/24	M-F / 7:00 am – 9:00 pm Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	<b>Test pit drilling</b> (Noise / Vibrations / Drilling within site perimeter to probe for previous site utilities / Minimal dust expected with mitigation practices to be employed)
10/28/24 – 11/1/24	M-F / 7:00 am – 9:00 pm Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	<b>Debris and Waste Trucking</b> (Noise / Removal of concrete, soil, and buried building remnants from the excavated site / Flaggers will direct pedestrian and vehicular traffic as necessary)

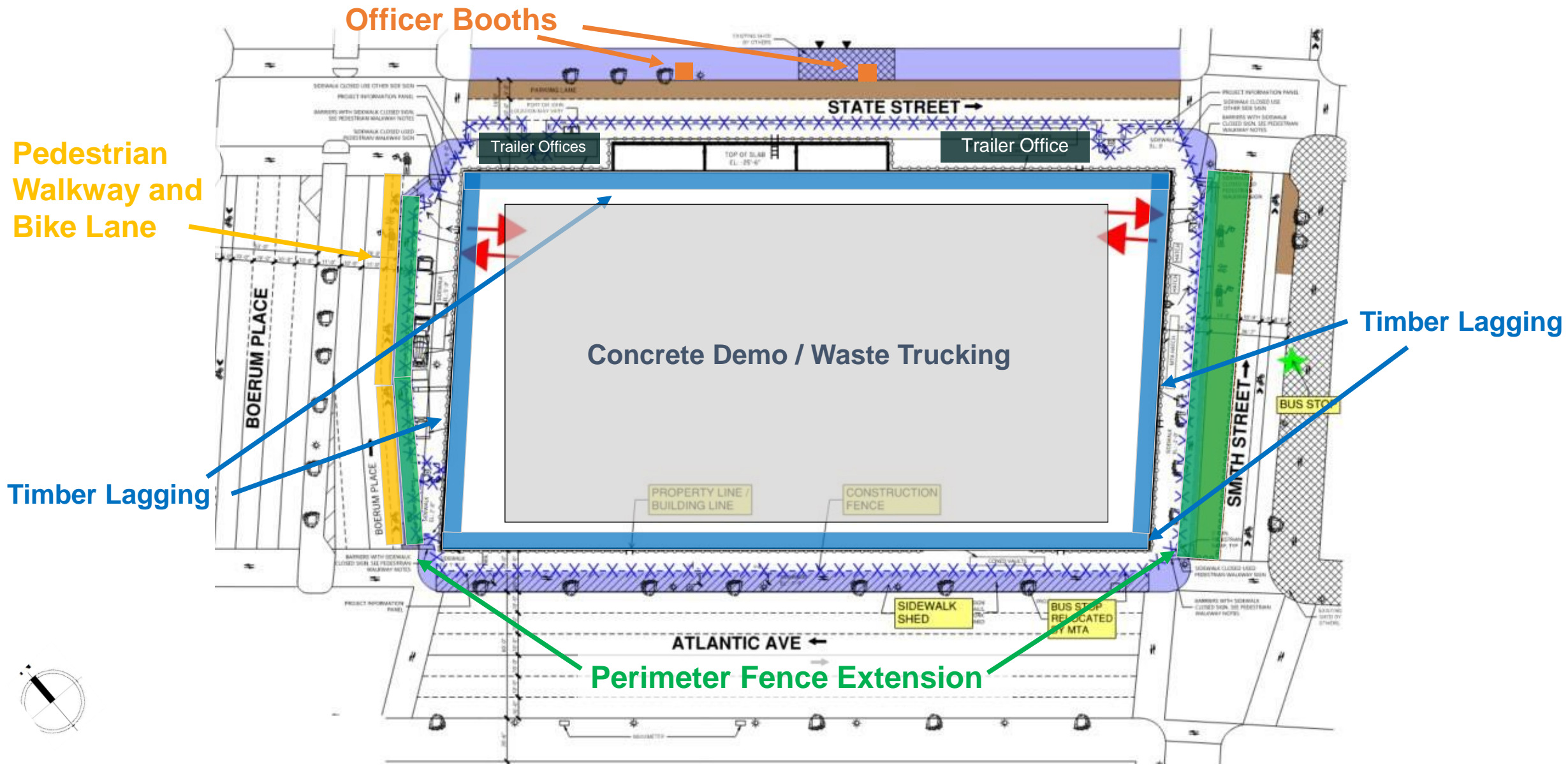
