

11/4/24 - 11/8/24	M-F / 7:00 am - 9:00 pm	(275 Atlantic Avenue)	State St. perimeter fence extension (Noise / Extending existing perimeter fence north / Capturing parking lane, and reducing vehicular egress to one lane / Flaggers will direct pedestrian and vehicular traffic as necessary)
11/7/24 - 11/8/24	M-F / 7:00 am - 9:00 pm	(275 Atlantic Avenue)	Watermain installation (Boerum PI.) (Noise / Installation of new watermain along Boerum PI. / Work will take place inside the site perimeter with no public interaction)
11/4/24 - 11/8/24	M-F / 7:00 am – 9:00 pm Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	Soil excavation and timber lagging (Noise / Removal of soil around the perimeter of the site / Truck deliveries of Wood to the site / Creation of wooden barriers in front of the structural soldier piles to prevent soil from falling inward)
11/4/24 - 11/9/24	M-F / 7:00 am – 9:00 pm Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	<b>Debris and Waste Trucking</b> (Noise / Removal of concrete, soil, and buried building remnants from the excavated site / Flaggers will direct pedestrian and vehicular traffic as necessary)
