11/25/24 – 11/30/24	M-F / 6:00 am – 12:00 am Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	Test pit drilling (Noise / Vibrations / Drilling within site perimeter to probe for previous site utilities / Minimal dust expected with mitigation practices to be employed)
11/25/24 – 11/30/24	M-F / 6:00 am – 12:00 am Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	Sheet Driving (Noise / Possible continuous vibrations / Machine vibrating installation of metal sheets into the soil in preparation for constructing the building core)
11/25/24 – 11/30/24	M-F / 6:00 am – 12:00 am Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	Debris and waste trucking (Noise / Removal of concrete, soil, and buried building remnants from the excavated site / Flaggers will direct pedestrian and vehicular traffic as necessary)

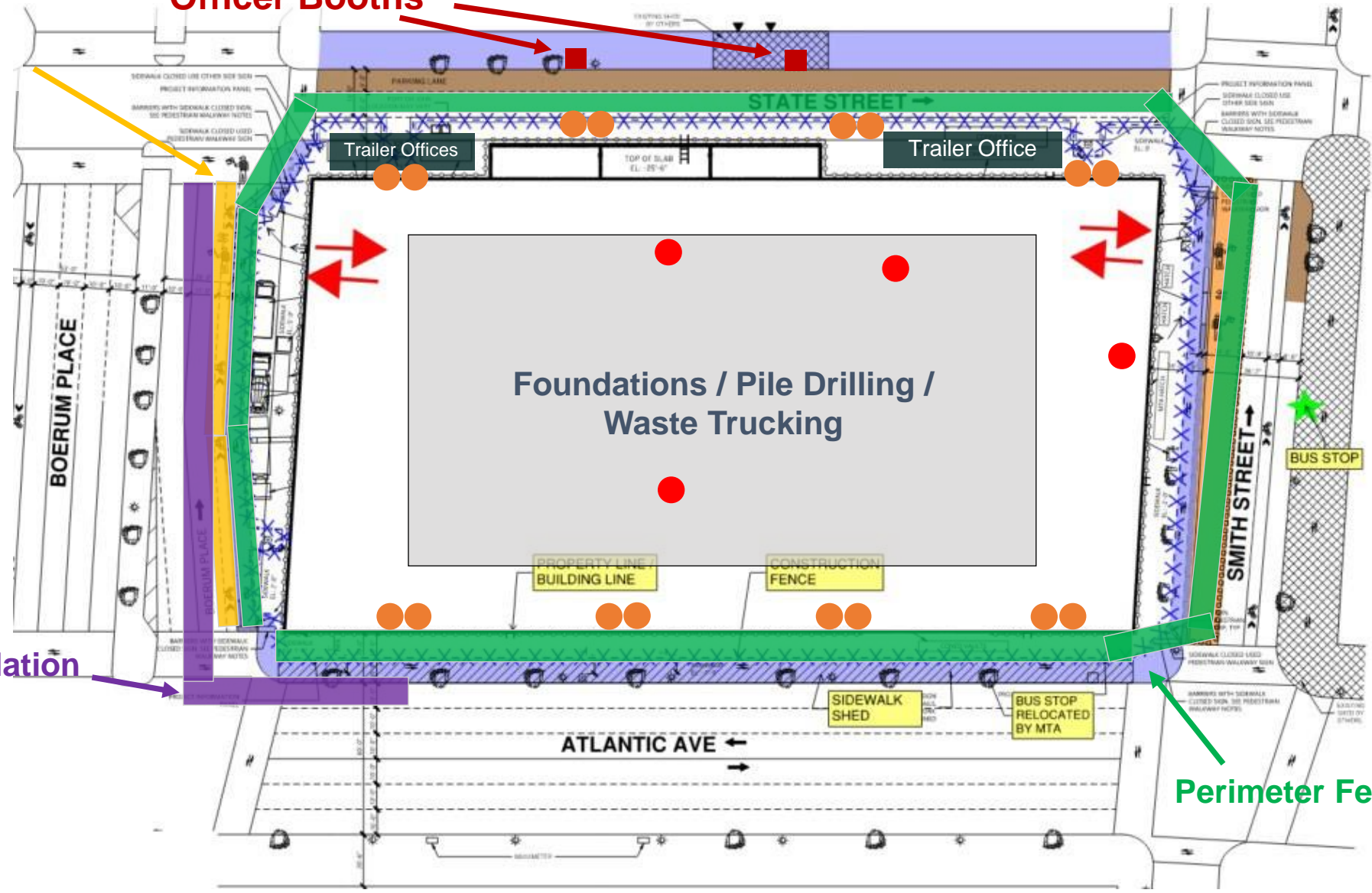
