1/6/25 – 1/10/25	M-F / 6:00 am – 12:00 am	(275 Atlantic Avenue)	Foundation construction (Noise / Vibrations / Excavating soil and installation of structural, electrical, and mechanical components for the crane and building foundations / Work will take place inside the perimeter fencing with no public interaction)
1/6/25 – 1/11/25	M-F / 6:00 am – 12:00 am Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	Pile drilling (Noise / Vibrations / Drilling within site for foundation and crane structural support piles / Minimal dust expected with mitigation practices to be employed)
1/6/25 – 1/10/25	M-F / 6:00 am – 12:00 am	(275 Atlantic Avenue)	Installing de-watering system (Noise / Pump installed to remove underground water for further preparation of constructing the building foundation and core / Pump will run 24/7)
1/6/25 – 1/10/25	M-F / 6:00 am – 12:00 am	(275 Atlantic Avenue)	Smith St. MTA vent shoring (Noise / Reinforcing MTA subway vents for operational safety / Work will take place inside the perimeter fencing with no public interaction)
1/6/25 – 1/10/25	M-F / 6:00 am – 12:00 am	(275 Atlantic Avenue)	State St. NYPD bollard installation (Noise / Vibrations / Installing additional bollard into the sidewalk around the NYPD booth for increased operational safety)
1/6/25 – 1/11/25	M-F / 6:00 am – 12:00 am Sat / 9:00 am – 5:00 pm	(275 Atlantic Avenue)	Debris and waste trucking (Noise / Removal of concrete, soil, and buried building remnants from the excavated site / Flaggers will direct pedestrian and vehicular traffic as necessary)
