OUR FOCUS: INTAKE AND ADMISSIONS

Objective

Develop a set of goals for the intake process and experience in future jails along with recommended strategies for improving the admissions process, the physical design of the intake space, and the interactions that take place during this process.

Key components of the intake process that we hope to explore include:

- Information gathering and sharing;
- Supervision, movement, and tracking;
- Physical design;
- Human interactions; and
- Use of technology.

NEW ADMISSIONS PROCESS TODAY

New admissions to Rikers Island (male adults)

COURT DIVISION PROCESSING (4 HOURS)

- Take detained person into custody after arraignment
- Conduct search, check detained person's property, and other processes
- Initial data entry

TRANSFER TO RIKERS ISLAND RECEIVING ROOMS (4 HOURS)

- Male adult detainees are accepted to new admission receiving rooms to continue processing
- The new admissions process is overseen by the Office of Custody Management/ New Admission Movement Control Unit (NAMCU)
- DOC has established policies around feeding new detained people and informing them of available medical services and how to access them

DOC AND MEDICAL PROCESSING (4 HOURS)

- New admissions complete all necessary paperwork
- Money and property is collected
- Photo identification and fingerprints are taken
- A search is conducted
- Shower
- Clinic

HOUSING ASSIGNMENT (4 HOURS)

- Housing is assigned based on a detained person's classification
- Classification decisions are based on information regarding an individual's personal information, and criminal and institutional history; classification is reassessed every 60 days
- Placement into a special housing category may result from assessment of an individual's medical, mental health, security and/or other identified need

BEST PRACTICES IN INTAKE

Across human services, the intake process is best when it is...

- Effective in gathering information needed to triage clients and make key decisions (e.g., urgent and emerging needs);
- Safe for all those involved;
- Efficient for both staff and clients;
- Consistent across various points in the process;
- Informative for people experiencing intake;
- Trauma-informed and responsive to people in crisis; and
- Protective of confidential or personal information.



GUIDING PRINCIPLES FOR DESIGN


Intake spaces

Intake is the critical juncture at which people enter the jail system. The physical setting for entry into the jail system should facilitate a consistent, dignified, fair, and transparent process for transition into custody.

The environment should be clearly organized, calm, and support adequate time and space for complete intake assessment, with easy access to related service providers.

The space should also ease and encourage access to information about the intake process through wayfinding, signage, and direct communication with staff and officers.





SELECT DESIGN STRATEGIES

- Consider open booking
- Provide areas for services and connecting detainees to programming
- Provide information, signage, and other resources to explain the intake process
- Ensure the incorporation of technology and other contemporary means of information gathering
- Provide everyday and healthy materials, furnishings, and fixtures
- Provide easier ways for staff to enter and exit the facility separate from intake areas


